When to use this form

Use this form if you have:

- 1. had your academic qualifications assessed via:
 - i a Form 16 (initial assessment) application
 - ii a Form A1 (initial assessment) application
 - iii a Form A2 (prospective or final assessment) application
 - iv a Form A3 (incomplete unaccredited or over 5 years old qualifications) application.

and/or

- 2. had your practical legal training qualifications and experience assessed via:
 - i a Form 17 (initial assessment) application
 - ii a Form P1 (initial assessment) application
 - iii a Form P2 (NSW Government) application
 - iv a Form P3 (incomplete unaccredited or over 5 years old training) application.

AND the period of validity for you to complete further study and apply for admission as set out in the LPAB's assessment letter(s) is about to expire or has expired*

*IMPORTANT – if you have completed the academic requirements for admission at an institution other than the LPAB and have not submitted an application in Form A2 for a final assessment to confirm that the study completed has provided you with the academic qualifications prerequisite for admission, do **NOT** apply for an extension. Instead, submit an application in Form A2. The decision in respect of the Form A2 application will include the grant of a fresh 2-year period of validity, during which you will need to complete all remaining requirements for admission and apply for admission.

Please ensure you complete each part of the form. Your application may be delayed if you have not followed the instructions or completed each part.

You can fill in the form electronically, or you can print the form and fill it in by handwriting.

What to do if your application for extension is refused

When issuing an initial decision on an application for assessment, the LPAB expects that the applicant will make every effort to satisfy the requirements for admission and apply for admission by the expiry date of the period of validity granted to them. This is to ensure that the applicant's knowledge remains as current as possible.

While the LPAB does allow for applicants to seek extension, the success of the application may depend on the age of the applicant's law degree and/or practical legal training course, and the potential lack of currency of the legal knowledge acquired when getting that qualification, and whether the applicant has been engaged in law-related work since receiving their initial assessment(s) so as to maintain the currency of the applicant's knowledge.

If your application for extension is unsuccessful, you may either:

- 1. apply for a review to the Legal Qualifications Committee (the Committee). Your application for review should be in a letter addressed to the Committee and include any new information to support your original submission (no fee), OR
- 2. lodge a fresh application for assessment (fee applies).

If your application for review to the Committee is unsuccessful, you will need to lodge a fresh application for assessment.
